On July 15, 1946 [ ] reported that BOB KAUFMAN was being considered for the position of Educational Director of a branch of the Waterfront Section of the Communist Party in New York City.

[ ] Confidential Informant [ ] of known reliability, reported that a National Maritime Training School had been conducted by the Communist Party from March 18, 1946 to April 19, 1946 at [ ] advised that among the students who had attended the school was BOB KAUFMAN.
